Ordered that Edward Beahamp be Overseer of the Road from where Sara-
ma Maddox leaves of to Madams Hampton's Lower Mill and from William Bensons to Marunisco
Dam &c

Ordered that Ralph Milbourn be Overseer of the Road from Madam Hampton's
Lower Mill down to Powhatan to Speckles point &c

Ordered that Jeanque Piquet
be Overseer of the Roads from Harris's Bridge to Thomas Beckett's plantation &c

Ordered that Matthew Hopkins be Overseer of the Road ^{from} Boqueton to the Road to John
Boger's Bridge

Ordered that Johnson Hill be Overseer of the Road from Circle Tree Hill
to Boqueton's branch &c

Ordered that Philip Selby be Overseer of the Road
from Circle Tree Hill to the line that divides Somerset County from Virginia &c

Ordered that Hugh Fingle Junr be Overseer of the Road from the head of Indian Town Creek
to Burch's branch &c

Ordered that Thomas Collins be Overseer of the Road from Bottle
Bridge to Burch's branch &c

Ordered that William Walton be Overseer of the Road from
the Three Runn Bridge to Baltimore Town and that he and Isaac Marshall be Overseers

Ordered that Richard Hudson be Overseer of

Ordered that William Burton be Overseer of the Road from Cow bridge at the head of
the Indian River half way to Broad Creek Bridge till he meets with John Windsor who

is appointed Overseer to clear half of his Usuals Limits &c And from Widow Donchoes
On peppers Creek to William to William Burtons Junr Sawmill &c

Ordered that Sarrus
Maddox be Overseer of the Road from Dividing Creek Bridge to his Branch as Usual and

from Circle Tree about three quarters of a mile beyond Stevens's Branch into the Road that leads to
the Gun House &c

Ordered that Christopher Doodle be Overseer of the Road from Stephen Coston
Dams at the head of Dividing Creek to Jarvis's bridge's &c

Ordered that John Lay be Overseer
of the Roads from the three Runn Bridges to Buckingham Bridge and from the Main Road that

leads to Sinepuxon Down a New point Neck &c

Ordered that Andrew Smith be Overseer of
the Roads from William Wood's plantation to Madam Hampton's plantation at the Sea Side

and from thence to the Road that leads to Buckingham &c

Ordered that John Hammond be
Overseer of the Roads from Dukebury Bridge to Mr. Frawitt's branch &c from thence to the great

Bridge over the head of Pochomoke &c
