Roads from Bottles bridge to Duke's Bay Branch &c. Ordered that George Trevitt be Overseer of the Road from M<sup>d</sup> Davis's branch to the great bridge and from thence into the County road & from thence to marsh field &c. Ordered that Moses Drushill be Overseer from Lodowicks Savannah to the Long bridge at Wicahomoco River

Ordered that Day Scott be Overseer of the Road from the Lower ferry over Wicahomoco River along the Road to Galloway tree and the Road that leads down the neck toward Samuel Flewings, that is from the Ferry road to the great Branch, and also the road from Stegney Church to the said Lower ferry &c.

Ordered that Robert Hardy be Overseer of the Road from Stegney Church up Wicahomoco River to the great Road that leads from Thomas Humphrys to the Upper ferry over Wicahomoco River, and from the upper side of Bartlett plantation to the said Ferry &c.

Ordered that John Windsor be Overseer in Nanticoke hundred from Broad Creek bridge to the head of William Burton's Quitts &c.

Ordered that Stephen Tolley be Overseer of the Roads in Nanticoke hundred from Quantico Mill to Springhill Chappell &c. Ordered by the Court that John Caldwell just be Overseer of the

Road in Wicahomoco hundred from Windsor Bridge to James King &c. Ordered by the Court that Ebenezer Hardy be Overseer of Ditto hundred from Steeveses Bridge to Coxes branch and

from the Long Bridge to the Cypress Bridge to his former bounds &c. Ordered by the Court that Thomas Hearne be Overseer of the Road from James King to Coxes Branch and that the Road

from James King to the Cypress Bridge be no longer a County road but that a new road be cleared from said King's Oodex Branch to Stevenses Bridge according to the Directions of said Caldwell

and Ebenezer Hardy &c. Ordered by the Court that William Weatherly be Overseer of the Road in Nanticoke hundred from Quantico Mill to Baron Creek mill &c. Ordered by the Court

that Edward Hellum be Overseer of the Road from Nanticoke ferry and make good crossings thro' the Marsh that leads to Senaj's Ferry and from thence to Richett's Road above Spring Hill

Chappell &c. Ordered by the Court that Nathaniell Waller be Overseer from Turkey Branch to Windsor Bridge Over broad Creek &c. Ordered that Edmond Hough be Overseer of the Road

from Newcongoe Bridge along the road to a small Branch just beyond M<sup>d</sup> Morris's and from M<sup>d</sup> Morris's to Snowhill Ferry and from Newcongoe to Snowhill Ferry. Ordered that Stanton

Dixie be Overseer of the Road from James Trevitt's Bridge to the great Bridge at the head of Coquomoko River and from thence to a little Branch just by M<sup>d</sup> Morris's &c. Ordered that

Thomas Gillis be Overseer of the Roads from William Alexander to Richard Blinnett's &c. Ordered that

W<sup>m</sup> Gray be Overseer of the Road from Windsor bridge Over Drappers Mill to Grassy branch &c. Ordered by the Court that Adam Spence just be Overseer of the Roads from

Boquet Norton Branch to the County Road up the sea side and likewise thro' a swamp called Aaron Swamp &c. Ordered by the Court that George West be Overseer of the Roads in Baltimore

hundred from the head of the Indian Town Branch Over a Beaver Dam into the Road by George Howard's plantation and from Cesar Godius up the River to Peppers Creek &c.

Ordered by the Court that Francis Neubold be Overseer in a Nanticoke hundred from Drappers Mill to Morgan's Road Over the Head of Nanticoke and to have all the labourous about Deep Creek &c.
