Thereupon Command was given to the Sheriff of Somerset County that he should take the said
 Rebecca Borter if he to answer it and afterwards to wit the Eighteenth day of June and send her
 thow and Seven hundred and thirty four before the Justices of his Lordship's County Court of Somerset here
 hold at Dividing Creek in and for the County of same the said Rebecca Borter in her proper person and
 being by the Sheriff sett to the bar is thereupon instantly demanded how she would acquit herself of the
 premises and says that of the premises and she upon her Imposed she is guilty thereof but to further
 to declare the father or begetter of the Child she stands Inducted for, and is willing to pay her fine for the
 fact and so ----- Whereupon all and Singular the premises by the Court here she heard and fully
 understood It is Considered by the Court here that the said Rebecca Borter pay to his Lordship the Lord
 Proprietary for her fine by the Court here upon her Imposed for and by Quasion of the premises and whoso

 Sterling of his body goods or Chattels Lands or tenements to the Use of the Officers of Somerset County
 Court On Case he both not pay and Satisfie unto the several Officers their fees due by means of the
 premises and Likewise it is ordered by the Court here that the said Rebecca Borter give Security
 for to save and keep harmless as well the Justices of Somerset County Court and their Successors for the
 time being as also the Inhabitants of the same County from all Costs Charges and troubles by reason of the
 birth and maintenance nourishing and bringing up of the bastard Child lately begott on her Body as afo
 re. Whereupon the said Wm. Callin present heron Court as afo and acknowledges himself to be Inducted unto his
 Lordship the Lord Proprietary in the sum of twenty pounds Sterling of his goods and Chattels Land
