Whereupon the said Thomas Lambden present herassi Court acknowledged himselfe to be Indebted unto his Lordship the Lord Proprietary in twenty pounds Sterling of his goods and Chattells Lands and tenements to be made and Levied to the Use of Somerset County if it happen that the said Thomas Lambden do not from time to time and at all times hereafter acquit discharge and save harmless as well the Justices of Somerset County Court and their Successors for the time being as also the Inhabitants of the same County of and from all Costs Charges troubles and burthens what soever for and by reason of the birth maintenance nourishing and bring up of the said Child and from all Suits troubles Charges and demands what soever touching or concerning of the same &c.

The Same

Thomas Larrimore Ind. Came herassi Court and prays that his Appearance may be levied to save himselfe and Security of and from aforesaid Recognizance of bail by him and Security before that time Entered into &c. Thereupon the said Thomas Larrimore Appearance is levied and he and his Security accordingly discharged.

Whereupon the said Thomas Larrimore Ind. is ordered to give new Recognizance for his appearance before the Justices of his Lordship's County Court of Somerset to be hold at Dowidnight next in the County of Somerset the third Wednesday of August next to answer unto his Lordship of and concerning his Committing of fornication with aforesaid Alice Hopkins &c.

Thereupon the said Thomas Larrimore Ind. with John Larrimore of Somerset County planter his Security both present herassi Court with their proper persons acknowledged their debts to owe and be Indebted unto his Lordship the Lord Proprietary in the sum of twenty pounds Sterling each of their severall goods and Chattells Lands and tenements to the Use of his said Lordship his heirs and Successors to be made and Levied if it happen that the said Thomas Larrimore Ind. do not make his personall appearance before the Justices of his Lordship's County Court of Somerset to be hold at Dowidnight next the third Wednesday of August next, and do not answer unto his said Lordship of and concerning his Committing of fornication with the said Alice Hopkins, and do not stand and abide the Indictment of the Court thereupon and do Depart the same Court without Leave thereof &c.

Alice Hopkins appears according to her Recognizance Entered into, to give Evidence against aforesaid Thomas Larrimore Ind. and she and her Security is accordingly discharged from the same Recognizance &c. whereupon the same Alice Hopkins is ordered
