Webb the third Day of June which was in the Year of Our Lord God Seventeen Hundred and thirty four at Somerset County afo by his certain Writing Obligatory had Granted himself to be bound Unto the afo Peter in the afo Sum of Nine pounds Seventeen Shillings & Eight pence Current Money of the province afo to be paid Unto the same Peter when thereof afterwards he should be Required Nevertheless the afo John Webb altho often Required the afo Nine pounds Seventeen Shillings & Eight pence Current Money afo Unto the afo Peter hath not paid but that Unto him hither to to pay altogether hath Refused and Still doth Refuse to the damage of the same Peter Ten pounds Curr. Money of Maryland and thereupon he bringeth Suit &c. and doth bring hereinto Court the Writing Obligatory afo which the Debt afo in form afo doth Testifie the Date whereof is the same Day and Year afo &c. —

Whereupon the said John Webb by William Beseningham his attorney Comes and Defends the force and Injury when &c. and Says that he cannot deny the action afo of the afo Peter Stewart nor can he say but that the writing Obligatory afo is the deed of him the same John Webb nor but that he Owes the same Peter Stewart the afo Nine pound seventeen shillings and Eight pence Current money in manner and form as the afo Peter Stewart above against him hath ~~been~~ declared wherefore the same Peter pray Judgment for his debt afo and his damages by Evasion of the detaining of the same debt to him to be adjudged &c. —

Therefore it is Considered that the afo Peter Stewart Recover against the said John Webb his debt afo and his damages afo by Evasion of the detaining of the same debt to One hundred and seventy seven — — — — — pounds of Tobacco to the same Peter Stewart ^{by the Court} of his afo &c. —

Money of the province afo which to him he Oweth Unjustly detains &c. —
And whereupon the said Peter by Geo: Douglas his Atty says that whereas the afo
Patrick Burk on the first day of June and Dom Seventeen hundred & thirty four at Somd. afo
Within the Juris of this Court by his certain Writing Obligatory had Granted himself to be bound
to the said Peter in the afo Sum of seven pounds four Shillings & four pence Curr. Money afo
to be paid to the said Peter when thereof afterwards Required Nevertheless the said Patrick
afo often Required the afo seven pounds four Shillings & four pence to the afo Peter hath
not paid but the same to him to pay altogether hath Refused & Still doth Refuse to the damage
