

Made in No Sort Regarding but minding & fraudulently Intending the same Timothee in this part Craftily and Subtilly to Deceive and Defraud the afofe Seven pounds thirteen Shillings or Any penny thereof to the same Timothee hath Not paid or bin for the same in Any Sort Contented altho' to do the same the afofe Robert afterwards to Wit the first Day of July in the Year and at the place afofe and often afterwards by the same Timothee was Required but that to him hitherto to pay or bin for the same in Any Sort to Content the same Robert altogether hath Refused and Still Doth Refuse to the Damage of the same Timothee fifteen pounds Six Shillings Current Money and Thereof he brings Suit ^{to}

Whereupon the said Robert Downs in his own proper person ^{Pledges} ^{for Doe} came here into Court and thereupon the said Robert Downs at the prayer of the afofe Timothee Haudson by his Attorney afofe is Adjudged to Give Speciall Bail to the action afofe Thereupon a certain James Martin of Somerset County Gent. present here in Court in his proper person Under Take for the said Robert Downs that if in Case the said Timothee Haudson Should Recover Judgment in the plebe afofe Against the said Robert Downs or that the said Robert Downs Should be there in Convict that then he the said Robert Downs Should pay the Condemnation of the Court thereupon or Render his body to the custody of the Sheriff of Somerset County in Satisfaction thereof or that he the said James Martin Will do the same for him ^{or} — Thereupon the said Robert Downs by George Douglas his attorney comes and

Defends his force and injury when ^{he} and prays Leave therof to Imparle here until next Court and he hath it and the same day is given to the afofe Timothee here also he

At which said next Court to wit the nineteenth day of March and Anno One thousand seven hundred and thirty three came againe as well the afofe Timothee Haudson as the afofe Robert Downs by their attorneys afofe and whereupon the afofe Robert prays further Leave therof to Imparle here until next Court and he hath it and the same day is given to the afofe Timothee here also he

At which said next Court to wit the eighteenth day of June and Anno One thousand seven hundred and thirty four came againe as well the afofe Robert Timothee Haudson as the afofe Robert Downs by their attorneys afofe and whereupon the said Robert Downs as before defends the force and injury when ^{he} — and says that he hath not affimed upon himselfe in manner and form as the said Timothee above against him hath Complained and of this he putteth himselfe upon the Country — and the afofe Timothee in like manner

Thereupon it is Commanded the Sheriff of Somerset County that he immediately he shoulde cause to Come here before the Justices of his Lordships County Court of Somerset now in Court Sitting and in the Creek in the County afofe twelve ^{or} by whom he and who neither he to recognize ^{he} because as well ^{he} and afterward immediately cause Name of the Jury ^{to} and then more of that same Jury by Joshua Caldwell Gent. Sheriff of the County afofe to this Commanded being Called come to with Adam Spence Ind.
