Francis the Justice here awarding to act of assembly in such case made and provided assessed the damages of
the said Francis by Breach of the promise and assumption of beyond his Costs and Charges by him about
his Suit in that part assessed to Nine hundred and Seven pounds of Tobacco &c -

Therefore it is considered by the Court here that the said Francis Allen recover against the said
John Bishop his damages as to the said Nine hundred and Seven pounds of Tobacco in form as by the
Justice as assessed as also Two hundred & Sixty Seven ----- pounds of Tobacco
for his Costs and Charges to the said Francis by the Court here of his appeal adjudged & the said Defendant

of Maryland and Avalon Lord Baron of Baltimore &c To the Sher^{iff}.

of Somerset County greeting we Command you that you Attach Any of
the Goods Chattels Rights or Credits of Robert Holland late of Somerset County Merch^t if they
shall be found in your bailiwick to the Value of One hundred & three pounds fifteen Shillings and
Two pence Curr. Money & two thousand pounds of Tobacco and when you have the same Attached or
any part thereof the same in your Custody safe keep so that you have the same before Our
Justices of Our County Court of Somerset to be held at Darding Creek the Third Tuesday of March
Next then and there to be condemned according to Act of Assembly to and for the Use of a certain
Robert Bolton Unless the said Robert Holland by himself or his Attorney shall appear and
Answer unto the said Robert Bolton in a plea of Trespass upon the Case &c according to Law
and that by Good and Lawfull Men of your bailiwick you Make known unto the person
or persons in whose hands you Make the same Attachment that he she or they be and
appear before Our Justice of Our County Court to be held as aforesaid to show Cause if any he
she or they have why the same Goods Chattels Rights or Credits so Attached in his her or
their hands Ought not to be condemned and Execution thereof had and Made according to Act
of Assembly in such case made and provided if to him her or them it shall seem Meet and
how you shall Execute this Writt that you Make known unto Our said Justices at the
Day and place aforesaid and have you then and there this Writt Witness Robert King Gent Chief
Justice of Our said Court the Twenty Ninth Day of November in the Nineteenth Year of
Our Dominion &c And Dom One thousand Seven hundred and thirty three - At which
said Third Tuesday of March to witt the Nineteenth Day of the same Month and
Dom One thousand Seven hundred and thirty three being the Day of the Return of
