And the afd Samuel Hopkins Jurd garnishes of the afd Robert Holland by William Beekingham his attorney Comes and prays Leave thereof to Impare hereunto until next Court and he hath it and the same day is given to the afd Robert Bolton here also & Att which said next Court to witt the Eighteenth day of June and Dow. One thousand seven hundred and thirty four came again as well the afd Robert Bolton as the afd Samuel Hopkins Jurd. by their attorney afd and thereupon the said Samuel Hopkins by his said attorney as before Comes and Saith that the afd Robert Bolton Endeavour of the premises so as afd attached in his hands to have Ought not because he Saith that he the said Samuel at the Day of the Saying the Attachment afd in his hands had not or at any Time since hath had any of the Goods Chattels Rights or Credits of the said Robert Holland in his hands and this he is ready to Verifie wherefore he prays Judgment if the afd Robert Bolton Endeavour of the premises so as afd attached in his hands to have Ought &c. afterwards to witt the Eighteenth day of June and Dow. One thousand Seven hundred & thirty four as afd the said Robert Bolton then and there his writ afd against the afd Samuel Hopkins garnish as afd did not prosecute <sup>with Effect</sup> but voluntarily permitted his suit to be discontinued &c.

Therefore Afterwards to witt the same day and year by direction of the Justice of his Lordship the said propriety here were adjudged to the said Samuel Hopkins Jurd. £100. hundred & Eighty five - - - pounds of tobacco for his Costs and Charges by him about his defence in that part Intended according to the form of the Statute in such manner of Use thereof lately made and provided and the afd Robert Bolton in mercy and the afd Samuel have thereof Breachon &c.
