In his Lordships County Court of Somerset before the Then Judges of the Same Court at Dividing Crook in the Same County by Consideration of the Same Court Recovered Against the Said William West by the Name of William West late of Somerset County Planter the aforesaid five pounds Twelve Shillings and three hundred and forty two pounds of Tob: which to the Same Edw: in the Same Court were Adjudged for his Damages which he had by Occasion of the Non performance of a certain Promise and Assumption to the Same Edw: by the aforesaid William made and not performed — whereof the aforesaid William is Convict as by the Record and proceedings thereof in the Same Court at Dividing Crook afo: Remaining Likewise fully Appareth which Certain Judgment Remaineth in full Strength force and Effect and no way Reversed or satisfied Nevertheless the aforesaid Edward Execution of the afores. five pounds twelve Shillings and three hundred and forty two pounds of Tob: as yet Remaineth to be made by which Action Accrued to the Same Edward to have and Require of the aforesaid William the aforesaid five pounds twelve shillings and three hundred and forty two pounds of Tob: Notwithstanding the afo: Edward Altho afo: Required the afo: five pounds twelve shillings and three hundred and forty two pounds of Tob: to the Same Edw hath not Rendered but the Same to him hitherto to Render altogether hath done and as yett Done wherof he says that he is worse and hath Damages to the Value of Eleven pounds four Shillings and six hundred and Eighty four pounds of Tob: and Hereof Produceth Suit &c.

Therefore it is Considered that the afo: Edward North Recover against the afo: William West his Debt afo: as also three hundred and Seventeen pounds of Tobans for his Damages but which he Sustained as well by Question of the detention of the Same Debt as for his Costs and Charges by him about his Suit in that part appoyed by the Just here of him about adjudged and the default: in mery &c.
