Who was Assignee according to the form of the Act of Assembly in such Case -  
Provided of Rob<sup>t</sup> Atkins of the City of Philadelphia in the Province of  
Pennsylvania Mariner of a plea that he Render unto him the full and Just  
Sum of one hundred and fifty pounds Curr<sup>t</sup> and Lawfull money of the Province  
of Pennsylvania of the Value of one hundred and fifty pounds Curr<sup>t</sup> Money of  
Maryland which to him he oweth and Unjustly Detaineth &c.

And Whereupon the same William Allen by William Beckingham his  
Attorney saith that Whereas the said Edw. the Twentieth day of June in the  
Year of our Lord one thousand Seven hundred and thirty at Somerset County by  
his Certain writing Obligatory had Granted himself to be held and firmly bound  
unto the aforesaid Robert Atkins in the aforesaid Sum of one hundred and fifty  
pounds Currant and Lawfull money of the Province of Pennsylvania aft<sup>r</sup> to be  
paid to the said Rob<sup>t</sup>. his Certain Attorney Ex<sup>o</sup>. Adm<sup>o</sup>. or Assignee when thereof after  
wards he should be Required and the aft<sup>r</sup> W<sup>m</sup> Allen in fact saith that the aft<sup>r</sup>. one  
hundred and fifty pounds Curr<sup>t</sup> and Lawfull money of the Province of Pennsylvania  
is of the Value of one hundred and fifty pounds Curr<sup>t</sup> money of this Province And the aft<sup>r</sup>  
William Allen further saith the aforesaid Rob<sup>t</sup>. Atkins after the Making the writing  
aft<sup>r</sup>. to wit on the fifth Day of June Anno Dom<sup>o</sup> Seventeen hundred and thirty one  
at Somerset County aforesaid the said one hundred and fifty pounds of the Value aft<sup>r</sup>  
or any penny thereof in no Sort paid or Satisfied being by his Certain writing  
of Assignment with the Seal of him the said Rob<sup>t</sup>. Sealed did Assigne and  
Make over unto the aforesaid Thomas Budd the writing obligatory aforesaid and  
the Money therein Mentioned whereof the aforesaid Edw. then and there had  
Notice and the aforesaid William Allen further saith that the aforesaid  
The Budd after the making the writing Obligatory aforesaid and the writ-  
ing Assignment aforesaid to wit on the Sixth Day of July Anno Dom<sup>o</sup>  
Seventeen hundred and thirty one at Somerset County aft<sup>r</sup>. the aft<sup>r</sup>. one  
hundred and fifty pounds of the Value aft<sup>r</sup> or any penny thereof in no Sort paid or  
Satisfied being by his Certain writing of Assignment with the Seal of the  
said The<sup>s</sup> Sealed did Assigne and make over unto the aforesaid William Allen  
the writing obligatory aft<sup>r</sup> and the Money therein Mentioned whereof the  
aft<sup>r</sup> Edw. then and there had Notice by Reason whereof as also by force of  
the Act of Assembly in such Case provided Action hath Accrued to the  
aforesaid William Allen to have and Require from the aft<sup>r</sup> Edw. the aft<sup>r</sup>.  
one hundred and fifty pounds of the Value aft<sup>r</sup>. Nevertheless the aft<sup>r</sup>. Edward  
altho after Required the aforesaid one hundred and fifty pounds of the  
Value aft<sup>r</sup> or any penny to the aft<sup>r</sup> W<sup>m</sup> Allen hath not Satisfied for
