At which said next Court to wit the eighteenth day of June and Done One thousand seven hundred and thirty four before at Dividing Creek before the Justices of the same Court Cometh the afo Nicholas Hodgson by his attorney afo and the Sheriff of the same County to wit Joshua Caldwell Esq. returned a certain Inquisition Indented and before him at the Court house in the County afo at Dividing Creek on the seventeenth day of June one thousand seven hundred and thirty four taken by which it appears that the afo Nicholas has sustained Damages by occasion of the non performance of the promise and assumption afo further than his Cost and Charges by him about his suit in that part appoyed to two pounds twelve shillings and three pence Current money and for those Costs and Charges to one pound of Tobacco

Therefore it is Considered that the afo Nicholas Hodgson recover against the afo James Pearsall his Damages afo by the Inquisition afo in form afo found also one thousand fifteen pounds of Tobacco for his Cost and Charges afo to the same Nicholas by the Court here of his afoent of Increase adjudged which for his Damages in the whole do amount to two pounds twelve shillings and three pence Current money and the afo defendt. in mercy &c

Kelsick and alexander maddox both of Somerset County in Maryland were Sumond to answer unto John Taylor of a plea that they render unto him sixteen hundred pence eight hundred in Tobacco and eight hundred in Corn which to him they owe and from him they Unjustly detain &c And whereupon the said John by Geo: Douglas his Attorney says that whereas the afo Tho. and alex. on the first Day of March and Done One thousand seven hundred & thirty Two at Somerset County within the Jurisdiction of this Court by their certain Writing Obligatory had granted themselves to be bound to the afo John in the afo sum of sixteen hundred pence eight hundred in tob. and eight hundred in Corn to be paid unto the afo John when thereof afterwards they should be required Nevertheless the said Tho. and alex. altho after required the afo sixteen hundred pence to the afo John hath not paid but the same to him to pay altogether have refused and still doth refuse to the Damage of the said John of Three thousand two hundred pence and thereof he brings Suit and brings herinto Court the Writing Obligatory afo which the Debt afo in form afo doth testify whose date is the same day & year afo &c Pledges &c John Doe &c R.
