and do not deliver up unto the said Eve Price or to her Guardian to be by her  
Chosen when she shall arrive at full age to her the same all her Estate  
personall that he shall have in his hands and possession peaceably and Quietly  
when ever the same shall be Legally Required of

his Servitude give him anew suit of Coaths over and above his Common wearing Coaths and  
Likewise provide for his said apprentice Sufficient meate drink washing Lodging and  
Clothing
