Whereupon it is ordered by the Court here that the said Levin Gale take into his care and possession the said Levin Demwood and all his Estate both Real and personal, and that a certain John Waters who Intermarried with the mother of the said Levin Demwood deliver up unto the said Guardian all the Estate of the said Levin Demwood that he hath in his hands both Real and personal, and further it is ordered by the Court here that the said Levin Gale give security for to comply with the Guardianship and Dr

Whereupon the said Levin Gale with David Wilson and Thomas Hayward of Somerset County ^{in Somerset} all present herein Court in their proper persons acknowledged themselves indebted unto the said Levin Demwood in two hundred pounds Sterling of their Bodys goods or Chattells Land or tenements to the use of the said Levin Demwood his heirs or assigns to be made and Levied if it happen that the said Levin Gale do not comply with the law in relation to such Guardians as Esq: and do not deliver up unto the said Levin Demwood or to his Guardian to be by him chosen when he shall arrive at full age to chose the same all his Estate both Real and personal that he shall have in his hands and possession peaceably and quietly when ever the same shall be Legally required &c

Know all men by these presents that we John Collins Alexander Marcy and Tho: Prely all of Somerset County in the Province of Maryland are holden and firmly bound unto W^m Collins Joshua Collins and Abel Collins orphans of Mary Collins dec: in the full and just sum of Sixty Seven pounds Eleven shillings and four pence Current money to be paid unto the said W^m Collins Thomas Collins Joshua Collins and Abel Collins their heirs Ex: or Assignes to the which payment well and truly to be made and done we bind ourselves our and either of our heirs Ex: and Assignes for the whole and in the whole Jointly and severally firmly by these presents sealed with our seal and dated this 21 day of Aug: Ann: Dom: 1734

The Condition of the above Obligation is such that whereas the Commissary General hath transmitted unto this Ct: the Account of the Estate of Mary Collins - dec: wherein it is found that there is Balance due to the abovesaid Orphans the sum of thirty three pounds fifteen shillings and eight pence Current money If therefore the abovesaid John Collins his heirs Ex: or Assignes shall and do well and truly pay or cause to be paid unto the above named W^m Collins Tho: Collins Joshua Collins and Abel Collins the sum of thirty three pounds fifteen shillings and eight pence Current money to be paid them in equal parts or portions according to act of Assembly in such case provided when they shall arrive at full age to receive the same then the above obligation to be void and of none Effect otherwise to stand and remain in full force and Virtue in Law -
