And the afd Thomas Lambert by Robert Jenkins Henry his attorney comes and defends the force and Injury when &c. and says that he cannot gainsay the action afd nor can he say but that the writing obligatory afd is the deed of the same Thomas nor but that he owes the same John Beaden the afd forty four pounds in gold or silver money of Maryland in manner and form as the afd John Beaden above against him hath declared wherefore the said plaintiff prays Judgment for his debt afd and the damages sustained by occasion of the detaining of that same debt to him to be adjudged &c.

Therefore it is considered that the afd John Beaden Recover against the afd Thomas Lambert his debt afd and his damages by occasion of the detaining of the same debt to three hundred & Two pounds of tobacco to the same John of his afd by the Court here adjudged and the afd Thomas in mercy &c.
