At which said next Court to with the fifteenth day of August Anno Domini One thousand Seven hundred and thirty two came again as well the said Luke Bowen as the said John Webb by their attorney and thereupon the said John prays further Leave ^{thereof} to Impare here until next Court and he hath it and the same day is given to the said Luke here also &c.

At which said next Court to with the Twenty first day of November Anno Domini One thousand Seven hundred and thirty two came again as well the said Luke Bowen as the said John Webb by their attorney and thereupon the said John prays further Leave ^{thereof} to Impare here until next Court and he hath it and the same day is given to the said Luke here also &c.

At which said next Court to with the Twentieth day of March Anno Domini one thousand seven hundred and thirty two came again as well the said Luke Bowen as the said John Webb by their attorney and thereupon the said John prays further Leave thereof to Impare here until next Court and he hath it and the same day is given to the said Luke here also &c.

At which said next Court to with the Nineteenth day of June Anno Domini one thousand seven hundred and thirty three came again as well the said Luke Bowen as the said John Webb by their attorney and thereupon the said John as before defends the force and Injury when &c. and saith that he did not Assume upon himself in Manner and form as the said Luke above against him hath complained and of this he puts himself upon the Country and the jury in like Manner.

Thereupon it was Comanded the Sher of Somerset County that judicially he should come to Court here before the Justice of his Lordships County Court of Somerset now in Court judicially sitting at Diording Crook Twelve &c by whom &c and who neither &c. to Recognise &c. because as well &c. and afterwards judicially came thereof the Jurors &c. and the Jurors of that same Jury by Joshua Catwell Gent Sher of the County aforesaid to this Jurament being called came to wit Wm Haddy Michl Dasher son John Webb Edw Bracham Joshua Sturgis - Hutton Hill John Johnson David Hudson Wm White David Howard Tho Collins and Tho Poal who to say the Truth of and upon the promises being Elcted - Tryed and sworn upon their Oath did say that the aforesaid John Webb did Assume upon himself in Manner and form as the aforesaid Luke Bowen above against
