 All which said third Tuesday of March to wit the Eighteenth day of the same month
 and: Dom: One thousand Seven hundred and thirty four being the day of the return of
 the said writ cometh the said Henry Truett by his attorney aforesaid and the sheriff
 of Somerset County to whom the foregoing writ was directed likewise comes and make
 return thereof to the Court Endorsed in these words following viz^t — ^{Legis} declarata
 in times delivered — J^r: Jos: M^r: Gaster Sheriff.

Whereupon the said Anthony Taylor being present here in Court in his proper person
 at the prayer of the said Henry Truett by his attorney aforesaid is adjudged to give special
 bail to the action aforesaid but for want thereof the said Anthony Taylor is committed into
 the custody of the Sheriff of Somerset County there to remain &c. the said Sheriff to
 wit Joseph M^r: Gaster Gents. present here in Court took charge of the said Anthony Taylor
 accordingly. And afterwards the said Anthony Taylor in his own proper person
 cometh and defendeth the force and Injury whereto and saith that he cannot gain say the
 action aforesaid of the aforesaid Henry Truett nor can he say but that he did assume upon himself
 in manner and form as the said Henry Truett above against him hath complained and as to the
 Damage of the same Henry by him by occasion of the premises in that part sustained the
 same Anthony saith and confesseth that the said Henry Truett hath sustained Damages
 by occasion of the premises beyond his Costs and Charges by him about his Suit in that
 assessed to five pounds two Shillings and three pence and three farthings Current money
 of Maryland and not more and because the said Henry deny^t not this but the same alle-
 gation confesseth to be true pray Judgment for those Damages above confessed together with
 his Costs and Charges aforesaid to him to be adjudged &c.

Therefore by Consent of the parties aforesaid it is considered that the said Henry Truett Recover
 against the said Anthony Taylor his Damages aforesaid to the said five pounds two Shillings and three
 pence three farthings Current money of Maryland in form aforesaid as also three hundred &
 Twenty Eight pounds of Tobacco for his Costs and Charges aforesaid to the same
 Henry Truett by the Court here and Consent of the parties aforesaid adjudged and the said Defendant in Maryland
 and afterwards to wit the Eighteenth day of March one thousand Seven hundred & thirty four the said Anth
 Taylor being present herein Court in his proper person and upon this the same Antho: is committed
 into the custody of the Sheriff of Somerset County there to remain until the said Henry of his Damages and Costs aforesaid
 should be fully satisfied, the said Sheriff to wit Jos: M^r: Gaster present took charge of the said Anthony accordingly.
