the said writt comette the said Henry Truett by his attorney aforesaid and the Sheriff  
of Somerset County to whom the foregoing writt was directed likewise comes and make  
return therof to the Court Endorsed in these words following vizt — <sup>Copy</sup> — ~~Copy~~ declarata  
in time delivered — J: M: Carter Sheriff.

Whereupon the said Anthony Taylor being present here in Court in his proper person  
at the prayer of the aforesaid Henry Truett by his attorney aforesaid is adjudged to give Special  
Bail to the action aforesaid but for want thereof the said Anthony Taylor is committed  
to the custody of the Sheriff of Somerset County hereto remain & the said Sheriff to  
wth Joseph M'Fester Gentleman present here in Court took charge of the said Anthony Taylor  
accordingly. And afterward the said Anthony Taylor in his own proper person  
cometh and defendeth the force and Injury whereof and saith that he cannot gainsay the  
action aforesaid of the aforesaid Henry Truett nor can he say but that he did assume upon himself  
in manner and form as the aforesaid Henry Truett above against him hath complained and as to the  
damage of the same Henry by him by occasion of the premises in that part sustained the  
same Anthony saith and confesseth that the aforesaid Henry Truett hath sustained damage  
by occasion of the premises beyond his costs and charges by him about his suit in that  
apposed to five pounds two shillings and three pence ~~—~~ three farthings currant money  
of Maryland and not more and because the aforesaid Henry denyeth not this but the same alle-  
gation confesseth to be true pray Judgment for those damages above confessed together with  
his Costs and Charges aforesaid to him to be adjudged &c.

Therefore by Consent of the parties aforesaid it is considered that the aforesaid Henry Truett recover  
against the aforesaid Anthony Taylor his damages aforesaid to the aforesaid five pounds two shillings and three  
pence three farthings currant money of Maryland in form aforesaid as also three hundred &  
Twenty eight pounds of tobacco for his his Costs and Charges aforesaid to the same  
Henry Truett by the Court here and Consent of the parties aforesaid adjudged and the aforesaid defendant in Maryland  
and afterward to wth the Eighteenth day of March One thousand Seven hundred and thirty four the said Anthony  
Taylor being present herein Court in his proper person and upon this the same Anthony is committed  
into the custody of the Sheriff of Somerset County hereto remain until the said Henry of his damages and Costs aforesaid  
should be fully satisfied, the said Sheriff to wth Jno: M'Fester present took charge of the said Anthony accordingly.
