

The Same Command was given to the Sheriff of Somerset County that he should take Donnock Dennis late of Somerset County planter if he should be found in his bailiwick and him should safe keep so that he might have his body before the Justice of ^{Somerset} County Court of Somerset to be held at Dividing Creek the third morrow of March then next to answer unto Robert Bolton of plea of her pass upon the case. and that those of his should not fail.

And the said Robert Bolton by Francis Allen his attorney complained against the said Donnock Dennis in the plea as followeth vid -
Somerset County s. Donnock Dennis late of Somerset County planter was attached to answer unto Robert Bolton of plea of her pass upon the case.

And whereupon the said Robert by Francis Allen his attorney complains that whereas the said Donnock the fourth day of February and four Eleven hundred and thirty two at the County of Somerset aforesaid within the jurisdiction of this Court was indebted unto the said Robert in three pounds two shillings and one penny Curr. money of Maryland for sundry properly chargeable in and as by and through hereunto annexed and herein Court produced may appear and being so indebted the said Donnock Dennis in consideration thereof the day and year aforesaid at the place aforesaid upon himself did assume and to the said Robert then and there did faithfully promise that he the said Donnock the said three pounds two shillings and one penny to the said Robert when he should be therunto requested well and faithfully he would pay and content. Nevertheless the said Donnock his promise and assumption aforesaid in form aforesaid made nothing regarding but plotting and fraudulently intending the said Robert in that part rashly and sully to deceive and defraud the said three pounds two shillings and one penny to the said Robert at the same to do the said Donnock by the said Robert on the fourth day of February in y^e year aforesaid and often afterwards at Somerset County aforesaid he was therunto requested he hath not contented but the same hitherto to him to pay or content hath refused and still doth refuse deny to the damage of the said Robert of six pounds Curr. money of Maryland aforesaid and thereupon he brings suit & pledges aforesaid *In Doe R. Roe*
