

we will not that you proceed in any of the Causes aforesaid to take life or member but that in every such Case you send the prisoners with their Indictments and the whole matters depending before you to our Justice of Assize nisi prius and final delivery at the next Court of Oyer and Terminer to be hold for our said County be it wheresoever ~~and~~ wheresoever to be holden there to be tryed And we Command you and every of you Diligently to Intend the keeping the peace acts of asembly Laws Customs and Statutes aforesaid and all and every the premises and that at your County Courts you make Inquisition and hear and determine as aforesaid doing therein ~~to~~ Justice appertaining according to the Laws Customs and directions of the acts of asembly aforesaid so far forth as they provide and where they are silent according to the Laws Statutes and Reasonable Customs of England as used and practized within this Province and further we do constitute ordain and appoint you the said Charles Calvert John Hall Richard Tilghman Mathias Tilghman Ward, John Rowby, Benjamin Tasker, Philip Lee John Rider Michael Howard George Slater Edmund Jennings, Robert King John Smith William Sloughton, John McEster John Handy, James Dashiell, John Scott, James Martin William Lane Thomas Williams Henry Ballard, David Wilson Edward Rownd and Charles Rashliffe or any three or more of you as aforesaid to Issue ^{out} writts precepts proceps and attachments and hold plea of all actions popular and of all actions personale of what sort soever wherein the Demand shall not Exceed the sum One hundred pounds Sterling or thirty thousand pounds of tobacco and all actions personale now depending before you and after Judgms Execution to award in all such Cases and actions aforesaid according to the Laws Customs and directions of the acts of asembly aforesaid so far forth as they provide and where they are silent according to the Laws Statutes and Reasonable Customs of England as used and practized within this Province in which said actions so to be tryed we do constitute ordain and appoint you the said Charles Calvert John Hall, Richard Tilghman, Mathias Tilghman Ward John Rowby Benjamin Tasker Philip Lee John Rider, Michael Howard George Slater, Edmund Jennings Robert King, John Smith William Sloughton John McEster John Handy, James Dashiell John Scott, James Martin Wm. Lane, Thomas Williams Henry Ballard David Wilson Edward Rownd and Charles Rashliffe and none others to be Judges also by these presents we do Command the Sheriffe of our said County of Somerset that at the severall Courts to be hold for our said County he give his attendance and come to come before you or any three or more of you as aforesaid such and so many good and Lawfull men of his Bailiwick out of Rank and every hundred thereof by whom the truth of the matters in the premises may be better known and Enquired of Lastly you shall cause to be brought before you at your said Courts all writts precepts proceps and Indictments to your Courts and Jurisdiction belonging that the same may be tryed and by due Course of Law determined
