Hugh Nelson } To the Worshipful the Justices now in Court sitting the humble petition of Hugh Nelson sheweth that whereas your petitioner hath a tract of Land called Poplar Hill now in his possession and being desirous to have the boundaries perpetuated begs that your worships will appoint such persons as you shall think proper to examine evidences in relation to the afo Land and your petitioner as in duty bound shall ever pray.

The petitioner afo being Read and heard and fully understood wherefore it is Considered that a Commission Issue to the afo Hugh Nelson as by the petition afo is said and that James Martin Edward Brown John Scarborough and Adam Spence Jnd. all of Somerset County be Commissioners and execute the same Commission according to act of assembly in such case made and provided &c.

Rachelle White } Rachel White a poor Child that hath neither father and mother to take care of her is bound to } bound by the Court unto Mary Stillee of Somerset County until her arrival at the age of sixteen years the said Rachelle White being four years old the fourteenth day of May last the said Rachelle White to serve her said Mistress the full term afo during which term the said Rachelle White her said Mistress well and faithfully shall serve her Secrets keep, her Commandments Lawfully and honestly every where willingly shall do and in all things as a good and faithfull servant shall demean herself towards her said Mistress and all hers during the term afo &c.

In consideration of which Service the said Mary Stillee present here in Court in her proper person Covenanteth with the Justices of the same Court, the Court Judicially sitting on behalf of the said Rachelle White that she the said Mary Stillee during the term afo will teach her said apprentice to Read well in the Bible and Knitt Sew and Spin and other housewifery and likewise find and provide for her said apprentice meat drink washing Lodging and Cloathing and all other necessarys sufficient for such an apprentice to have and wear during the term afo &c.

Whereupon it is ordered by the Court here that the afo Mary Stillee give Security for to Comply with the Covenants afo &c. Thereupon the said Mary Stillee with John Dennis Jnd. her Security both present here in Court in their proper persons and acknowledged themselves indebted unto the said
