afterward: here in Court came the said John and made Oath that he had Sumoned the said John White that he should
directly appear here in Court to answer the petition afo. and whereupon the said John White in his proper per-
son came here in Court, and the petitioner being present and thereupon at and Iniquity the premises by the
Court was being seen and the severale allegations as well on the part of the said John White as on the part of the said
petitioner being heard and mature deliberation thereupon had. It is therefore Considered by the Justice
here that the said ^{John} White pay unto the said William Carter all his freedom dues allowed by act of assembly
in such case made and provided as by the petition afo is paid &c.

His Lordship . . . Richard Swift appears according to his Recognizance for his appearance at this Court
Richard Swift . . . to answer his being Suspected of the feloniously taking the goods of a certain William Dolkin.
and thereupon his appearance is Recorded and he and his security accordingly discharged &c.
Whereupon the said Richard Swift is ordered to give new Recognizance for his good behaviour and
appearance at November Court next to answer on Suspicion of felony as afo &c.

Thereupon the said Richard Swift with David Wilson of Somerset gent. his Security both
present here in Court in their proper persons acknowledged themselves Indebted unto his Lordship the
Lord Proprietary in ten pounds Sterling each of their severale goods and Chattels Lands and Tenements
to the use of his said Lordship his heirs and Successors to be made and Levied, If it happen that the
said Richard Swift do not make his personall appearance before the Justice of his Lordship's County Court
of Somerset to be held at Dowding Beck the third Tuesday of November next and do not then and there
answer unto his said Lordship of and concerning his being Suspected to have feloniously taken the
goods of the said William Dolkin, and do not stand and abide the Judgment of the Court thereupon and do
depart the same Court without Leave thereof and in the meantime if he be not of the good behaviour
toward his said Lordship and all his good people &c.

The same . . . John Carnes . . . Whereas a certain John Carnes of Somerset County squire being present here in
Court in his proper person is ordered to give Recognizance in five pounds Sterling
for his appearance at November Court next to give Evidence on behalfe of his Lordship
against Richard Swift in Suspicion of felony. &c.

Thereupon the said John Carnes present here in Court as before acknowledged himselfe to be Indeb-
ted unto his said Lordship the Lord Proprietary in five pounds Sterling of his goods and Chattels Lands and
Tenements to the use of his said Lordship his heirs and Successors to be made and Levied If it happen that the said
John Carnes do not make his personall appearance before the Justice of his Lordship's County Court of
Somerset to be held at Dowding Beck the third Tuesday of November ^{next} and do not then and there give such Evidence
as he shall know of or concerning the said Richard Swifts feloniously taking the goods of William Dolkin, and do
depart without Leave of the same Court &c.
