also it is Considered that the said Thomas Bluett Recover against the said Thomas Dashiell yard of the said James Lura Two hundred and nine pounds of tobacco for his Costs and Charges by the Court here of his aforesaid adjudged and the said Debt in merye

W. A. William Robinson } Planter was Attached to Answer unto John Burnell of a plea of Trespass upon the Case

And Whereupon the said John by Francis Allen his Attorney Complain that whereas the said W<sup>m</sup> the second day of May Anno Dom<sup>o</sup> Seventeen hundred and thirty two at the County of Somerset aforesaid within the Jurisdiction of this Court was Indebted unto the said John in Eleven hundred Seventy four pounds of Tob<sup>o</sup> as by a certain note by the said William Assigned and herunto Annexed bearing Date the day and Year aforesaid may in Court appear and being so thereof Indebted the said William in Consideration thereof the day and Year aforesaid at the County aforesaid within the Jurisdiction Upon himself did Assume and to the said John then and there did faithfully promise that he the said William the said Eleven hundred Seventy four pounds of Tob<sup>o</sup> to the said John when he should be therunto Requested he would well and faithfully pay and Content Nevertheless the said William his Promise and Assumption aforesaid in form aforesaid made Nothing Regarding but plotting and fraudulently Intending the said John in that part craftily and subtilly to deceive and defraud the said Eleven hundred Seventy four pounds of Tob<sup>o</sup> to the said John Altho the same to do the said William by the said John on the aforesaid second day of May in the Year aforesaid and often afterwards at the County aforesaid within the Jurisdiction aforesaid he was therunto Requested hath not paid or Contented but the same to him hitherto to pay or Content hath refused and still doth refuse and deny Whereupon the said John saith he is worse and hath Damages to the Value of two thousand three hundred and forty eight pounds of Tob<sup>o</sup> and thereupon he brings Suit

Whereupon the said W<sup>m</sup> Robinson being Called appears. And thereupon the said W<sup>m</sup> Robinson at the prayer of the said John Burnell by his Attorney aforesaid is Adjudged to give Special Bail to the Action aforesaid thereupon a certain Justice Quaternus of Somerset County planter present here in Court assumed upon himself and undertook for the said W<sup>m</sup> Robinson that if in Case the said John Burnell should Recover Judgment in the plea aforesaid against the said William Robinson or that the said
