On the same Court were adjudged for her Damages which she sustained by Detention of the Detaining of that same Debt whereof he was convicted and it was ordered by the same Court that the said Sarah have Execution against the said James by his Default for the Debt and Damages aforesaid.

At which said third Tuesday of August to wit the Twenty first Day of the same Month Anno Domini, One thousand Seven hundred and thirty three being the day of the Return of the same writ came the said Sarah Stewart by Francis Allen her Attorney aforesaid and the Sher of Somerset County then being to wit Joshua Caldwell Gent. at the same Day Returned upon the writ aforesaid that he by Virtue of the same writ to him directed took the Body of the said James Shirley whose Body before his Lordships Justices at the Day and place aforesaid in the writ aforesaid mentioned he had there ready. Thereupon the said James Shirley present here in Court at the prayer of the said Sarah Stewart by her Attorney aforesaid is committed into the Custody of the Sher of Somerset County there to Remain until the said Sarah of the Debt and Damages aforesaid should be fully satisfied. The said Sher to wit Joshua Caldwell Gent. present here in Court took Charge of the said James Shirley accordingly.

Command was given to the Sher of Somerset County that he should take James Shirley Gentle. One of the Attorneys of Somerset County Court if he should be found in his Bail with and him should save so that he might have his Body before the Justices of his Lordships County Court of Somerset to be held at Diving Creek the third Tuesday of August then next to satisfy Robert Watson of four pounds Cash and two hundred and thirty two pounds of Tobacco which to the same Robert in the same Court before the Justices there of at Diving Creek in the County aforesaid were adjudged for his Damages which he had by Breach of a certain promise and assumption to the same Robert by the said James made and not performed whereof the same James is guilty.

At which said third Tuesday of August to wit the Twenty first Day of the same Month Anno Domini One thousand Seven hundred and thirty three being the day of the Return of the same writ came the said Robt Watson by Francis Allen his Attorney aforesaid and the Sher of Somerset County then being to wit Joshua Caldwell Gent. at the same Day returned upon the writ aforesaid that he by Virtue of the same writ to him directed took the Body of the said James Shirley whose Body before his Lordships Justices at the Day and place aforesaid in the writ aforesaid mentioned he had there ready.

Thereupon the said James Shirley present here in Court at the prayer of the said Robt Watson by his Attorney aforesaid is committed into the Custody of the Sher of Somerset County there to Remain until the said Robt of the Damages aforesaid should be fully satisfied. The said Sher to wit Joshua Caldwell Gent. present here in Court took Charge of the said James Shirley accordingly.
