On the same Court were adjudged for her Damages which she sustained by Detention of the Detaining of that same Debt whereof he was convicted and it was ordered by the same Court that the afd Sarah have Execution against the afd James by his Default for the Debt and Damages afd.

At which said third Tuesday of August to wit the Twenty first Day of the same Month Anno Domini, One thousand Seven hundred and thirty three being the day of the Return of the same writ came the afd Sarah Stewart by Francis Allen her Attorney afd. and the Sher of Somerset County then being to wit Joshua Caldwell Gent. at the same day Returned upon the writ afd. that he by Virtue of the same writ to him directed took the Body of the afd James Shirley whose Body before his Lordships Justices at the day and place afd. in the writ afd. mentioned he had there ready. Thereupon the said James Shirley present here in Court at the prayer of the afd Sarah Stewart by her Attorney afd. is committed into the Custody of the Sher of Somerset County there to Remain until the said Sarah of the Debt and Damages afd. should be fully satisfied. The said Sher to wit Joshua Caldwell Gent. present here in Court took Charge of the said James Shirley accordingly.

Command was given to the Sher. of Somerset County that he should take James Shirley Gent. One of the Attorneys of Somerset County Court if he should be found in his Bail with and him should save so that he might have his Body before the Justices of his Lordships County Court of Somerset to be held at Diving Creek the third Tuesday of August then next to satisfy Robert Watson of four pounds Cash and two hundred and thirty two pounds of Tobacco which to the same Robert in the same Court before the Justices there of at Diving Creek in the County afd. were adjudged for his Damages which he had by Breach of a certain promise and assumption to the same Robert by the afd James made and not performed whereof the same James is guilty.

At which said third Tuesday of August to wit the Twenty first Day of the same Month Anno Domini One thousand Seven hundred and thirty three being the day of the Return of the same writ came the afd Robt Watson by Francis Allen his Attorney afd. and the Sher of Somerset County then being to wit Joshua Caldwell Gent. at the same Day returned upon the writ afd. that he by Virtue of the same writ to him directed took the Body of the afd James Shirley whose Body before his Lordships Justices at the day and place afd. in the writ afd. mentioned he had there ready.
