 ring the term aforesaid &c.

In consideration of which Service the said Benjamin Aydelott present here in Court
 in his proper person Covenanteth with the Duties of the Peace Court, in Court Judicially sitting on behalfe of
 the said Elizabeth Pepper, that he the said Benjamin Aydelott during the term and will Learn his said appren-
 tice to read well in the bible and at the Expiration of her Service give his said apprentice a spinning wheel
 of Rush or that is of Linnen and woolling and anew Suit of Cloathes over and above her Common wearing Cloathes
 and Likewise provide for his said apprentice meat drink washing and Lodging and Bathing and all other
 necessary Sufficient for such an apprentice to have and wear during the term and &c.

Whereupon it is ordered by the Court here that the aforesaid Benjamin Aydelott give Recognizance with
 one Surety for to comply with the Covenants aforesaid &c.

Thereupon the said Benjamin Aydelott with Benjamin Holland of Somerset County planter his Surety both
 present here in Court in their proper persons and acknowledged themselves Indebted unto the said Elizabeth Pepper
 in the Sum of five pounds Sterling good and Lawfull money each of their Several goods and Chattels
 Land and tenements jointly and Severally to be made and Levied to the use of the said Elizabeth Pepper
 her heirs or assigns If it happen that the said Benjamin Aydelott do not during the term and Learn his said
 apprentice to read well in the bible, and at the Expiration of her Service do not give his said appren-
 tice a spinning wheel of Rush or that is of Linnen and woollen and anew Suit of Cloathes over and above
 her Common wearing Cloathes, and Likewise do not provide for his said apprentice meat drink washing
 Lodging and Bathing and all other necessary Sufficient ^{for such an apprentice} to have and wear during the term and &c.
