All Which said next Court to witt the twentieth day of November ^{one thousand Seven hundred & thirty three} and also as well the apd
Samuel Odham as the apd Thomas Billing by their attorney apd ^{whereupon} the Same Thomas Billing defendeth the
force and Injury when &c. and Saith that he did not asume upon himselfe in manner and form as the apd
Samuel above against him hath Complaind and of this he puts himselfe upon the Country &c.

Whereupon the apd Thomas prays that the apd Samuel may Reply to his plea apd But the Same Samuel
at the Same day altho. Solemnly called Cometh not nor to the plea of the apd Thomas to Replyeth, nor is his writt
and declaration apd against the Same Thomas further prosecuted &c.

Therefore it is Considered by the Court here that the apd Samuel Odham take nothing by his writt and
Declaration apd but that he and his pledgers of prosecuting to witt John Doe and Richard Roe be in merry
and that the apd Thomas go thereof without Day &c. And further it is Considered that the apd Thomas Billing

for his Costs and Charges by him about his defence in that part Sustained to the same Thomas by the Court here
