His Lordship the Right Honourable the Lord Proprietary Comanded  
the Sheriff of Somerset County by his writ in these words following  
Somerset & Charles absolute Lord and Proprietary of the

provinces of Maryland and Avalon and Baron of Baltimore To  
The Sheriff of Somerset County greeting we command you that you attach any  
the goods chattles rights or credits of Hugh Arbuthnot late of London Merchant  
Deceased if they shall be found in your bailiwick to the Value of eighteen pounds Nineteen  
Shillings and eleven pence sterling money and one thousand pounds of tobacco  
And when you have the same attached or any part thereof the same in your  
Custody safe keep so that you have the same before our Justices of our Coun-  
ty Court of Somerset to be held at Diving Creek the third Tuesday of August  
Next then and There to be condemned according to act of assembly to and  
for the use of a certain John Tunstall unless that Nathaniel Hoche James  
Peirce and John Wood late of London merchants and Administrators of all  
singular the goods and Chattles Rights or credits of the aforesaid Hugh  
Arbuthnot deceased by himself or his attorney shall appear and answer  
unto the said John Tunstall in a plea of Trespass upon the Case & according  
to law and that by good and Lawfull men of your bailiwick you make  
Attachment that he she or they be and appear before our Justices of our  
County Court of Somerset to be held as aforesaid to shew cause if any he  
she or they have why the same goods chattles rights or credits so at-  
tached in his her or their hands ought not to be condemned and Executi-  
on thereof had and made according to act of assembly in such case ma-  
de and provided if to him her or them it shall seem meet and how you  
shall execute this writt that you make known unto our said Justices  
at the day and place aforesaid and have you then and there this writt  
Witness Robert King Gentleman chief Justice of our said Court the  
Twenty fifth day of June In the Nineteenth year of our Dominion  
Anno Domini One thousand Seven hundred and thirty Three

At which said Court on the twenty first day of the same month and Day One  
thousand Seven hundred and thirty three being the day of the return of the said writt Cometh the said John  
Tunstall by his attorney <sup>Rob. Jenkins Esq.</sup> and the Sher. of Somerset County to whom the foregoing writt was directed  
Likewise Cometh and maketh Return thereof to the Court here Endored in these words following  
By Vertue of the within writt to me directed to the Justices of Somerset County Court I  
Do certifie that on the fourteenth day of August one thousand seven hundred and  
thirty three I did attach of the goods and chattles of Hugh Arbuthnot in the hands  
of Andrew Thompson and for the use of Captin John Tunstall to the Value of  
Eighteen pounds Nineteen Shillings and eleven pence Sterling and one thousand  
pounds of Tobacco and before William Horsey and John Horsey good and Law-  
full men of my Bailiwick I made known to the aforesaid Andrew Thomson  
that he be and appear att the time and place appointed to shew cause if any  
he she or they hath why Judgment may not pass as aforesaid to answer  
Joshua Caldwell Sher

And the said Andrew Thompson Esq. as aff by Francis Allen his attorney Comes and pray Leave them-  
selves to In. park here until the next Court and he hath it and the same day is given to the said John Tunstall  
here also & At which said next Court to wit the Twentieth day of November and Day  
One thousand Seven hundred and thirty three came again as well the said John Tunstall as the said
