Ordered by the Court here that Elizabeth Game pay unto Sarah White and Eliz<sup>th</sup> Nicholson one hundred  
and twenty pounds of tobacco each for their attendance four days as Evidence, each on behalf of his  
Lordship against the said Elizabeth Game they having made Oath to the same &c.

Ordered by the Court that Richard Swift pay unto John Carter one hundred and fifty pounds of tobacco  
being due unto him for his attendance five days as an Evidence on behalf of his Lordship against Richard  
Swift he having made Oath to the same &c.

Ordered by the Court here that Richard Swift pay unto William Doldens thirty pounds of tobacco being due  
unto him for his attendance as an Evidence three days on behalf of his Lordship against the said Richard  
Swift he having made Oath to the same &c.

Ordered by the Court here that Mary Burke pay unto Abraham Jones thirty pounds of tobacco for his  
attendance one day as an Evidence on behalf of the said Mary Burke against Thomas Lambden he having  
made Oath to the same &c.

Ordered by the Court here that Theodore Bere pay unto John Scarbrough or other one hundred and twenty  
pounds of tobacco for his attendance four days as an Evidence on behalf of the said Theodore Bere against Tom  
Andrews he having made Oath to the same &c.

Ordered by the Court here that Johnson Hill pay or cause to be paid unto John Burnall thirty pounds  
of tobacco for his attendance three days as an Evidence on behalf of the said Johnson Hill against Philip  
Selby he having made Oath to the same &c.

¶ B. Anthony West } Command was given to the Sheriff of Somerset County that he should take  
¶ William West } William West late of Somerset County planter otherwise called William West of  
Somerset County in the province of Maryland planter if he should be found in his County  
and him should safe keep so that he might have his body before the Justices of his Lordships County  
Court of Somerset to be held at Bridgwater Creek the third Tuesday of June then next to answer unto Plaintiff  
West of a bill that he tender unto him one hundred pounds current money which to him he doth and  
willfully defrauded him — At which said third Tuesday of June to wit the nineteenth day of the same  
month and year One thousand Seven hundred and Thirty three being the day of the return of the same with cause  
the said Anthony West by William Bentingham his attorney ¶ and the Sheriff of Somerset County to whom the  
foregoing writ was directed Likewise comes and makes return thereof to the Court here bid ordeid in these  
words following Capi Corpus propositus ad eum scilicet &c.

¶ And the afo<sup>d</sup> William West by Francis Allen his attorney comes and defendeth the force and injury  
whereof and prayeth leave thereof to Imparte hereunto next Court and he hath it and the same  
day is given to the afo<sup>d</sup> Anthony West here also &c.

At which said next Court to wit the twenty first day of August and Two One thousand and  
Seven hundred and thirty three came againe as were the afo<sup>d</sup> Anthony West and the afo<sup>d</sup> William West by  
him
