Ordered by the Court here that Mary Burke pay unto Abraham Jones thirty pounds of tobacco for his attendance one day as an Evidence on behalfe of the said Mary Burke against Thomas Lambden he having made oath to the same.

Ordered by the Court here that Theodore Bore pay unto John Scarborough or Order one hundred and twenty pounds of tobacco for his attendance four days as an Evidence on behalfe of the said Theodore Bore against William Andrews he having made oath to the same.

Ordered by the Court here that Johnson Hill pay or cause to be paid unto John Bunnale thirty pounds of tobacco for his attendance three days as an Evidence on behalfe of the said Johnson Hill against Philip Selby he having made oath to the same.
