Proclamation being made in writing and the Sheriff of Somerset County to witt —
Joseph Mifflin Gent. being called makes return of the panel of the Orphan Jury as followeth —
Joshua Edward Christopher Piper, John Larimore Joshua Sluger, Tom Adams, David Beacham, Cornelius Dickerson, William Gray, Maurice John Hellen, John Aydelott, John Estes, Thomas Larimore, John Bevin, Richard Hutchinson Hutton Hale, James Houston Underwood Rember that were all being severally called over did appear and were sworn and charged and sent out to consider the soon after the Orphan Jury being impanelled, sworn and charged as and returned here unto Court and being severally called over did appear and being asked if they had agreed on any presents answered no whereupon they were discharged —

To the inhabitants of the worshipfull court now sitting the humble petition of Nehemiah Holland and most of the neighbours in Mattaponi neck humbly pray your worship to appoint persons to Lay a road from Virginia line to girdle tree hill it being laid out in accordance to the line it being several miles nearer for people to pass up and down the County as your petitioners shall ever pray Nehemiah Holland, John Burnale, Fisher Walton, William Aydelott, Bowden Robins, Johnson Hale which being laid and heard and the premises considered It is therefore ordered by the Court here that Master William Lane and John Burnale make at certain time and place by them to be appointed so soon as possible and Lay out also and cause the same to be cleared from the Road that parts Virginia from Somerset County near the plantation of Silas Chapman to girdle tree hill and that the said Road be laid out and paved the Nearest & Best way and of the last of prejudice to any person or persons that shall be overseer of the same Road &c
