 the Jurisdiction aforesaid did Lend and deliver unto the aforesaid John Britt the aforesaid Six pounds &  
 fourteen Shillings currant money as aforesaid in Money numbered and the same John Britt then and there did  
 take and receive the same money and the said Attorney of the said Lord Proprietary for the same Lord  
 Proprietary doth further give the same Justices here to understand and be informed that the aforesaid  
 John Britt afterwards to witt the aforesaid tenth day of October and Dated Seventeen hundred Thirly and  
 Three aforesaid at the parish aforesaid in the County aforesaid and Jurisdiction aforesaid in further per-

 and Three aforesaid until the said tenth day of October their next following corruptly usurpos-  
 ing and against the form of the act of assembly in such case lately made and provided did
