vined of Maryland planter was Summoned to
answer unto Edward Rownd in a plea of he render unto him eight
pounds fourteen Shill. and eight pences current money of Maryland
and one thousand pounds of tobacco which to him he oweth and
unjustly detaineth &c.

And whereupon the same Edward by Robert Jenchins Henry his
attorney saith that whereas the affd. Wrixham the Twentieth day of
March in the year of our Lord one thousand seven hundred thirty
and four at Somerset County aforesaid within the Jur. of this Court
by his certain ^{writing} obligatory did acknowledge himself to be held and
firmly bound unto the same Edward in y. aforesaid eight pounds
fourteen Shill. and eight pences and one thousand pounds of
Tobacco to be paid to y. same Edward when he should be therewith
requested Nevertheless the aforesaid Wrixham altho' often therunto
requested the aforesaid eight pounds fourteen Shillings and eight
pences and one thousand pounds of tobacco unto the same Edward
he hath not as yet rendered but the same to him hitherto to render
hath refused and still doth refuse and deny wherefore he saith
that he is the Wove and hath damage to the value of eight
pounds fourteen Shill. and eight pences and one thousand pounds
of tobacco and thereof bringeth Suit &c. and bringeth herinto
Court the writing aforesaid within y. debt affd. in form afores.
doth testify whose date is y. same day and year affd. &c.

And the aforesaid Wrixham Cragger by George Douglas his
attorney cometh and defendeth the force and Injury wherof and
saith that he cannot gainway the action affd. of the affd. Edward Rownd
nor but that the writing obligatory affd. is the deed of him the same
Wrixham nor but that he oweth the same Edward the affd. eight
pounds fourteen Shill. and eight pences current money affd. and
one thousand pounds of tobacco in manner and form as the affd.
Edward above against him hath declared &c.

Therefore it is considered that the aforesaid Edward Rownd recover
against the aforesaid Wrixham Cragger his debt affd. and his damages
by occasion of the detaining of the same debt to ^{one hundred & seventy}
pounds of tobacco to the same Edward of his
