Alexander Munro being summoned to appear at this Court for not burning of tobacco according to act of assembly in such case made and provided by & forasmuch as it doth not appear to the Court here that the said Alexander Munro hath nothing to object wherefore he had not burnt the tobacco aforesaid Therefore the said Alexander Munro is fined twenty shillings curr^t money by Occasion of the premises aforesaid

Walter Morgan being summoned to appear at this Court for not burning of tobacco according to act of assembly in such case made and provided by & forasmuch as it doth not appear to the Court here that the said Walter Morgan hath nothing to object wherefore he had not burnt the tobacco aforesaid Therefore the said Walter Morgan is fined twenty shillings curr^t money by Occasion of the premises aforesaid

Benjamin ffusque being summoned to appear at this Court for not burning of tobacco according to act of assembly in such case made and provided by & forasmuch as it doth not appear to the Court here that the said Benjamin ffusque hath nothing to object wherefore he had not burnt the tobacco aforesaid Therefore the said Benjamin ffusque is fined Twenty shillings curr^t money by Occasion of the premises aforesaid Thereupon the said Benjamin ffusque present herein Court is committed into the custody of the Sheriff of Somerset County th^t to remain until he satisfies the fine aforesaid and all the officers fees due by Occasion of the premises aforesaid
