

Thereupon a certain Thomas Adams of Somerset County planter present here in Court in his proper person -
 undertook for the said John Jenkins and acknowledged himself Indebted himself Indebted unto his Lordship
 the Lord Proprietary in the Sum of Twenty pounds sterling of his goods and Chattells Lands and tenements to the use
 of his said Lordship his heirs and Successors to be made and Levied If it happen that the said John Jenkins
 Do not make his personall appearance before the Justices of his Lordship's County Court of Somerset to be
 hold at Dwiding Beck the third Tuesday of June next and do not then and there give such Evidence as he
 knows on behalf of his said Lordship against the said John Jenkins and Thomas Blizzard of and concerning
 a certain trespass and assault by them supposed to be committed and done and do depart the same Court
 without Seaworth

His Lordship - { Somerset County } The Jurors for the right honourable the Lord Proprietary
 Timothy Haley = Henry that now is for the body of Somerset County aforesaid upon their oaths
 do present that Timothy Haley late of Somerset parish in the County aforesaid Taylor
 the twentieth day of October in the Year of our Lord God Seventeen hundred and thirty five with
 force and Arms at the parish aforesaid in the County of within the Jurisdiction of this Court one Gold
 Chisel of the Value of twenty pounds of the goods and Chattells of Rep^r John Tunstall there
 being found then and there feloniously did steal take and bear away contrary to the peace of the said
 Lord Proprietary that now is his good rule and Government and against the form of the act of Parli-
 ament in such force lately made and provided.

For John Tunstall - On the backside of the foregoing Bill of Indictment it was then endorsed
 in these words following vizt. *Quia Vera* Samuel Wilson.

Thereupon Command was given to the Sheriff of Somerset County that he should take
 the said Timothy Haley if he to answer the same and afterwards to with the Sixteenth day of March
 anno Domini One thousand seven hundred and thirty five before the Justices of his Lordship's County
 Court of Somerset now here hold at Dwiding Beck in and for the same County came the said Timothy
 Haley in his proper person under Custody of the Sheriff of Somerset County into whose Custody before
 that time was taken for the cause aforesaid and being by the said Sheriff led to the Barr; and had
 a hearing of the Indictment aforesaid who says that he is not guilty thereof and of this he puts himself
 upon the Country and William Goldborough Gout his Lordship's attorney; and who for his said
 Lordship in that part followeth Likewise.

Thereupon it is Commanded the Sheriff of Somerset County that immediately he should
 come to come here before the Justices of the Twelve by whom the same and who neither he to recognize the
 because
