

His Lordship } Somerset County sh^{ts} The Jurors for the Right Honourable the Lord Proprietary of
 The Same } that now is for the Body of Somerset County and upon their Oath do present that Jeremiah
 Liley late of Coventry Parish in the County aforesaid did sometime the first day of January
 in the Year of Our Lord God Seventeen Hundred and thirty five with force and arms at the parish and in the
 County aforesaid within the Jurisdiction of this Court One pair of Shoes of the Value of thirty pounds of tobacco one
 white Linen Shirt of the Value of Sixty pounds of tobacco and one perriwig of the Value of two hundred
 pounds of tobacco of the goods and Chattels of Francis Porter then and there being found then and there felon-
 ously did steal take and bear away contrary to the peace of the said Lord Proprietary that now is his good
 rule and Government and against the form of the act of assembly in such Case lately made and provided
 To wit Joseph McFarter Francis Porter Joshua Menite.

On the backside of the foregoing Bill of Indictment it was thus Endorsed by the said Court
 Thereupon Command was given to the Sheriff of Somerset County that he
 should take the said Jeremiah Liley if he to answer &c. and afterwards to wit the sixteenth day of March
 and Term One thousand Seven Hundred and thirty five before the Justices of his Lordships County Court
 of Somerset now here held at Widnigreeke in and for the same County came the same Jeremiah Liley
 in his proper person under Custody of the Sheriff of Somerset County and being by the said Justices
 led to the Bar, and had a hearing of the Indictment aforesaid and being Instantly demanded how he
 would acquitt himself of the felony aforesaid as by the Indictment aforesaid above against him Sup-
 posed say that of the felony aforesaid above against him supposed he is guilty thereof and every thing in
 the Indictment aforesaid expressly Confesseth &c.

Whereupon all and Singular the premises by the Court here seen heard and fully understood
 valued the Shoes, white Linen Shirt and Perriwig aforesaid stolen amounting to act of assembly in such Case made
 and provided to two hundred and sixty pounds of tobacco. Thereupon it is considered by the
 Court here that the said Jeremiah Liley pay unto the said Francis Porter the party deprived four fold of
 the Value of the goods aforesaid stolen amounting in the whole to One thousand One hundred and Sixty
 of tobacco and that the said Jeremiah Liley be whipt at the publick whipping post with twenty stripes on
 the bare back well laid on until the blood appear and that he stand in the pillory one quarter of an
 hour and that he be taken &c. and thereupon as to the Corporall punishment aforesaid Command is given to
 the Sheriff of Somerset County that he do thereof Immediate Execution according to the Judgment aforesaid Rendered
 by whipping of the said Jeremiah Liley at the publick whipping post with twenty stripes on the bare back
 well laid on until the blood appear and by sitting him in the Pillory one quarter of an hour and after-
 wards in the same Court came the said Sheriff and made return that he had done the Execution of the Judgment
 aforesaid as to the Corporall punishment aforesaid he was Commanded &c. Wherefore it is considered ordered by the
 Court that the said Jeremiah Liley be sold for any time not exceeding seven years to the biggest bidder towards
 Satisfaction of the four fold aforesaid of the goods aforesaid stolen and as to the sale of the said Jeremiah
