The Same } is for the body of Somerset County aforesaid upon their Oath do present that Jeremiah Lilley
Late of Bredbury parish in the County aforesaid on the tenth day of January in the year of
Our Lord God Seventeen hundred thirty five with force and arms at the place parish aforesaid in the County aforesaid
within the Jurisdiction of this Court two Sackets of the value of fifty pounds of tobacco each of the
goods and Chittels of Obadiah Reed then and there being found then and there feloniously did steal take
and bear away contrary to the peace of the said Lord Proprietary that now is his good Duke of Government
and against the form of the act of assembly in such Case lately made and provided &c

On the backside of the foregoing bill of Indictment it was thus Endorsed by the said Court

Thereupon Command was given to the Sheriff of Somerset County that he should take the said Jeremiah
Lilley if he to answer &c and afterwards to wit the Sixteenth day of March and to wit one thousand seven
hundred and thirty five before the Justices of his Lordships County Court of Somerset now here holden at Durdin
Great in and for the Same County came the said Jeremiah Lilley in his proper person under Custody of the
Sheriff of Somerset County and being by the said Sheriff led to the Court here had a hearing of the Indictment
aforesaid and being Instantly demanded how he would acquitt himself of the felony aforesaid as by the Indictment
aforesaid above against him is supposed ~~whereupon says~~ that of the felony aforesaid above against him
supposed he is guilty thereof and every thing in the Indictment aforesaid Expressly contained &c

Whereupon also and singular the premises by the Court here been heard and fully understood thereupon
the Court here according to all of assembly in such Case made and provided valued the goods aforesaid stolen
to wit two Sackets in the Indictment aforesaid mentioned to fifty pounds of tobacco &c

Wherefore it is considered by the Justices here that the said Jeremiah Lilley pay unto Obadiah Reed
the party deprived four fold of the value of the Sackets aforesaid stolen amounting in the whole to
two hundred pounds of tobacco and that the said Jeremiah Lilley be whipt at the public whipping post
with ten stripes on the bare back well laid on until the blood appear and that he stand in the
pillowry one quarter of an hour and that he be taken &c and thereupon as to the Corporall punish-
ment the Command is given to the Sheriff of Somerset County that he do there of Immediate Execution
according to the Judgment aforesaid Rendered by whipping of the said Jeremiah Lilley at the public
whipping post with ten stripes on the bare back well laid on until the blood appear and
by setting him in the pillowry immediately one quarter of an hour, and afterwards in the same Court
came the said Sher. and returned that he had done the Execution of the Judgment aforesaid as to the Corporall punishment
aforesaid he was Commanded &c - Whereupon it is considered and ordered by the Court here that the said Jeremiah
Lilley be sold for any time not exceeding seven years to the biggest bidder towards Satisfaction of the four fold
aforesaid and the severall other fees due by occasion of the premises aforesaid, and as to the sale of the said
Jeremiah
