The same ... Somerset County &c. The Sher for the Right Honorable the Lord Proprietary that now is for
The same ... the body of Somerset County aforesaid do present that Jeremiah Gilley Late of Rowley
Parish in the County aforesaid Com waiver the first day of January in the year of our Lord God
Seventeen hundred and thirty five with force and arms at the parish afo in the County afo within the Jurisdiction
of this Court One pair of Stockins of the Value of thirty pounds of Tobacco of the goods and Chattells of M^r Kemney
Borster then and there being found there did there feloniously did steal take and bear away Contrary to the peace
of the Said Proprietary that now is his good Law & Government and against the form of the act of assembly in such case
made and provided by Acts Joseph M^r Borster Francis Borster, Joshua Merritt and M^r Kemney Borster.

On the backside of the foregoing Bill of Indictment it was thus Endorsed viz Billa vera &c. Joseph Merritt

Thereupon Command was given to the Sheriff of Somerset of Somerset County that he should take the said
Jeremiah Gilley &c. to answer &c. and afterwards, to wit the Sixteenth day of March and. Dom. One thou.
sand Seven hundred and thirty five before the Justice of his Lordship County Court of Somerset now here
held at dividing Creek in and for the same County came the said Jeremiah Gilley in his proper person under
Custody of the Sheriff of Somerset County and being by the said Sheriff Led to the bar, had a hearing of
the Indictment afo and being Instantly demanded how he would acquitt himselfe of the felony afo as by
the Indictment aforesaid above against him supposed says that of the felony afo above against him sup-
posed he is guilty thereof and Every thing in the Indictment afo Expressly Confesseth &c.

Whereupon all and singular the premises by the Court here seen heard and fully understood &c.
upon the Court here according to act of assembly in such case made and provided the pair of Stockins in
the Indictment afo stolen to thirty pounds of Tobacco.

Wherefore it is considered by the Justice here that the afo Jeremiah Gilley pay unto M^r Kemney
Borster the party deprived four fold of the value of the Stockins afo stolen amounting in the whole to one
hundred and twenty pounds of Tobacco and that the said Jeremiah Gilley be whipt at the publick whipping
post with fifteen Stripes on the Bare back well Laid on while the blood appear and that he stand
Immediately in the pillory one quarter of an hour and that he be taken &c. and thereupon as to the corporal
punishment afo Command is given to the Sheriff of Somerset County that he do there of Immediate Execution
according to the Judgment afo Rendered by whipping of the afo Jeremiah Gilley at the publick whipping post
with fifteen Stripes on the bare back well Laid on while the blood appear and by sitting him in the pillory
Immediately one quarter of an hour and afterwards in the same Court came the said Sheriff and
made return that he had done the Execution of the Judgment afo as to the corporal punishment afo he was
Commanded &c. whereupon it is considered and ordered by the Court here that the afo Jeremiah Gilley be sold
for any time not Exceeding Seven years to the biggest bidder towards Satisfying of the four fold afo and the
several Officers their fees due by Commission of the premises aforesaid and as to the Sale of the Said Jeremiah Gilley
Command is given to the Sheriff of Somerset County that he do there of the same Immediately &c
