Test. Willm. Hatfield. Abra. Jones. - Thereupon Command was given to the Sheriff of Somerset
County that he should take the said James Duffey if he to answer &c. And afterwards to wit the
Sixteenth day of March anno Dom. One thousand seven hundred and thirty five before the Justices
of his Lordships County Court of Somerset now here hold at Widning Creek in and for the
same County came the said James Duffey under Custody of the Sheriff of Somerset County into whose
Custody ^{before that time} was committed for the Cause aforesaid and being by the said Sheriff Ledd to the Bar had shew-
ing of the Indictment aforesaid who thereupon saith that of the trespass and assault aforesaid by the Indictment
aforesaid is above upon him Imposed he is guilty thereof. Whereupon all and Singular the premises
by the Court here seen heard and fully understood It is Considered by the Justices here that the said
James Duffey pay unto his Lordship the Right honorable the Lord Proprietary for his fine for by the
Court hereupon him Imposed for and by occasion of the trespass and assault aforesaid whereof in form aforesaid
he is found Twenty pounds Current money of Maryland and that the said James Duffey be taken to
Satisfie his said Lordship of the fine aforesaid ^{the day on the said James Duffey is committed to the Court here until he satisfy his said Lordship of the fine aforesaid} Likewise the said James Duffey is ordered
to give good Security for his good behaviour during the pleasure of the Court, but for want
thereof the said James Duffey is committed into the Custody of the Sheriff of Somerset County
thereto Remanied &c. the said Sheriff to wit Joseph McCarter Gent by Francis Dorkin deputy pre-
sent took Charge of the said James Duffey accordingly Likewise the said James Duffey is ordered
to give Security for the payment of the Soveraile Officers their fees due by occasion of the
Indictment aforesaid. but for want thereof the said James Duffey is committed into the Custody of
the Sheriff of Somerset County thereto Remanied &c. the said Sheriff to wit Joseph McCarter Gent
present ^{as aforesaid} took Charge of the said James Duffey accordingly &c
