the same Peter to the said Jacob hath not as yet paid or caused to be paid or  
the same in any sort Contented or Satisfied altho' the same to do the said Peter afterwards  
to witt the same day and year aforesaid at Somerset County aforesaid and often afterwards by the  
same, Jacob was thereunto requested but the same hitherto to pay or for the same  
in any sort to Content, the same Peter hath altogether refused and still doth  
refuse and deny whereupon the said Jacob saith that he is worse and hath  
Damages to the value of seven pounds Current Money of Maryland and there-

Whereupon Came hereto Court the said Peter fraser in his proper person and thereupon  
the said Peter fraser at the prayer of the said Jacob Cullen by his attorney aforesaid, is adjudged  
by the Court here to give Specifick Bail to the action aforesaid. whereupon Benjamin David Wilson  
of Somerset County Gent. present hereto Court undertook for the same Peter fraser and  
Assumed upon himselfe [Likewise the said Peter fraser assumed upon himselfe] that if  
in Case the said Jacob Cullen should recover Judgment in the plea against the said Peter  
fraser or that the said Peter fraser should be therein convicted that then he the said  
Peter fraser should pay the Judgment of the Court thereupon or tender his Body in Confinement  
of such Judgment to the prison of the Sheriff of Somerset County in Satisfaction hereof or that
