

All which said next Court to wit the Sixteenth day of March and the one thousand seven hundred & thirty five came againe as well the <sup>ap</sup> Robert Geddes as the <sup>ap</sup> William Beavis by their attorney, <sup>ap</sup> and whereupon the same William Beavis as before defends the force and injury when <sup>he</sup> and saith that he did not assume upon himselfe in manner and form as the <sup>ap</sup> Robert Geddes above against him both Complaind and of this he putteth himselfe upon the Country. and the <sup>ap</sup> Deft in like manner. ---

Whereupon the <sup>ap</sup> Robert Geddes by his attorney <sup>ap</sup> pray, the Justices here the said day and yeer last mentioned that they <sup>would</sup> proceed to and hear and determine the dispute in the action <sup>ap</sup> between him and the <sup>ap</sup> William Beavis according to the Rules of Equity and good conscience, according to act of assembly in such case made and provided. Whereupon the Justices here at the prayer of the <sup>ap</sup> Robert Geddes and by the consent of the <sup>ap</sup> William Beavis, having heard the severall allegations as well on the part of the <sup>ap</sup> Deft as the <sup>ap</sup> Deft and likewise examined the same Deft on Oath; and severall witnesses being sworn to testify in the premises. and all and singular the severall allegations of both <sup>ap</sup> Deft and Defend; and what was deliverd upon Oath, being by the Justices weighed and fully understood and mature deliberation thereupon had Wherefore it seeme to the Justices here that the <sup>ap</sup> Robt pray unto the <sup>ap</sup> William Beavis all his Costs and Charges by him expended as well at Common Law as Equity &c.

Therefore it is Considered and decreed by the Justices here that the <sup>ap</sup> Robert Geddes take nothing by his writt and declaration <sup>ap</sup> but be in money for his false Calumny and that the said William Beavis goe thereof without day and further it is Considered by the Justices here that the <sup>ap</sup> William Beavis Recovere against the <sup>ap</sup> Robert Geddes Eight hundred and fiftie ---  
783. --- pounds of Tobacco for his Costs and Charges by him about his defence as well at Common Law as in Equity expended unto the same <sup>ap</sup> by the Court the said Judge &c.
