Deit. remembered that William Goldborough Gent. attorney of the right honourable the Lord proprietary that now is who for the same Lord proprietary in this ^{part} prosecute doth come here into the County Court of the same Lord proprietary held for Somerset County aforesaid to witt at dividing Creek in the County aforesaid the sixteenth day of March in the year of our Lord God one thousand seven hundred and thirty five before John Smith Gent. and his associates the said Lord proprietary his Justices, of the same County Court and for the same Lord proprietary doth give the same Justices hereto understand and be informed that Isaac Knott late of Somerset County Carpenter the tenth day of January Anno Domini one thousand seven hundred and thirty five at the parish aforesaid in the County aforesaid within the Jurisdiction of this Court in and upon a certain John Kenney of the same County planter an assault did make and him then and there did beat wound and evilly treat so that of his life it was greatly despaired and other harms to him then and there did to the great damage of the same John Kenney and against the peace of the said Lord proprietary that now is his good rule and Government &c. Whereupon the same attorney of the said Lord proprietary for the same Lord proprietary prayeth the advise of the Court herein the premises and that due process of law in that part against the aforesaid Isaac Knott may be made to answer unto the same Lord proprietary of and upon the premises &c.

Thereupon Command was given to the Sheriff of Somerset County that he should take the said Isaac Knott to answer &c. and afterwards to witt the sixteenth day of March Anno Domini one thousand seven hundred and thirty five before the Justices of his Lordships County Court of Somerset now here held at dividing Creek in and for the same County came the said Isaac Knott in his proper person according to a certain recognizance by him and his Security before acknowledged and had a hearing of the Information aforesaid who thereupon saith that of the trespass and assault aforesaid as by the Information aforesaid above upon him is Imposed he is guilty thereof. Whereupon all Singular the premises by the Court here being seen heard and fully understood &c.

It is considered by the Justices here that the said Isaac Knott pay unto his Lordship the Lord proprietary for his fine by the Court here upon him Imposed for and by occasion of the trespass and assault aforesaid whereof inform aforesaid he is convicted two shillings and six pence current money of Maryland and that the said Isaac Knott be taken to testify his said Lordship of his fine aforesaid. Likewise it is ordered by the Court here that the said Isaac Knott give security for the payment of the severall Officers fees due by means of the premises aforesaid thereupon Henry Ballard of Somerset County Gent. present herein Court undertake for the said Isaac Knott for to pay the severall Officers fees due as aforesaid in full for the said Isaac Knott doth not pay the same &c.
