The petition aforesaid read and heard and fully understood wherefore it is considered by the Court here that the aforesaid Abraham Mason be discharged for the future from paying of Levies as by the petition aforesaid is prayd and allowed one pound of tobacco p year &c —

Whereas a certain Robert Malcome being ancient and infirm is by the Court here discharged from paying of Levies for the future and allowed one pound of tobacco p year &c.

Sarah Wilson negro girl & duncy is adjudged by the Court here to be of the age of Twelve years &c. Upon the petition of Sundry of the Inhabitants against Francis Lord for relation to a load he had laded by order of Court &c. It is hereby ordered that the said Francis Lord make the New load he had an order for in the Year 1725 good and passable at his own proper costs and charge &c —

Mary Tate negro Boy named Mercury is adjudged by the Court here to eight years of age this term &c.

Jacob Cullen negro boy named Joe is by the Court here adjudged to Eleven years of age this term.
