 Geo. Francis Allen -- } Somerset County ss. Jeremiah Wright Sale of Somerset County planter
 was attached to answer unto Francis Allen of a plea of trespass upon the case
 for Jeremiah Wright } And whereupon the said Francis by Geo. Douglas his attorney
 complains that whereas the said Jeremiah the third day of June A.D. 1755 twenty hundred and
 thirty at Somerset County within the Just of this Court had accounted with him the said Francis for sundry
 sum of tobacco by the said Jeremiah before that time due owing and unpaid And upon that acct was
 found in arrears to the said Francis in nine hundred and twenty six pounds of tobacco and being so the
 Indebted the said Jeremiah in consideration thereof upon himself did assume and then and there
 faithfully promised to pay the said Francis the aforesaid nine hundred and twenty six pounds of tobacco
 never the less the said Jeremiah tho' often required the said nine hundred and twenty six pounds
 of tobacco to the said Francis hath not paid but the same to pay hath refused and still doth refuse
 and deny to the damage of the said Francis of fifteen hundred pounds of tobacco and thereupon
 he bring suit pledges depts John do R. Rose

And whereupon the said Jeremiah Wright in his own proper person cometh and defend-
 eth the force and Injury whereof and saith that he cannot gainsay the action of the afo-
 Francis nor but that he did assume upon himself in manner and form as the afo Francis above
 against him complained and as to the damage of the same Francis by him by omission of the
 premises in that part sustained the same Jeremiah saith and confesseth that the aforesaid
 Francis has sustained damages by omission of the premises further than his costs and charges
 by him about his suit in that part apposed to nine hundred and twenty six pounds of tobacco
 and not more and because the afo Francis deny's not this but the same allegation confesseth
 to be true prays Judgment and those damages before confessed together with his costs and
 charges afo to him to be adjudged the

Therefore by consent of the parties and it is considered that the afo Francis Allen recover
 against the afo Jeremiah Wright his damages afo to the afo nine hundred and twenty six pound
 of tobacco in form aforesaid confessed also pounds of
 227 tobacco for his costs and charges aforesaid to the same Francis at his request by the Court here
 by the consent of the parties aforesaid adjudged and the afo Jeremiah in mercy the
