be found in his bail with and him should safeguard so that he might have his body before the Justice of his Lordships County Court of Somerset to be held at Dividing Creek in the same County the third Tuesday of June next to answer unto Charles Henderson of a plea of trespass upon the fact and that therefore he should not fail & At which said third Tuesday of June to wit the fifteenth day of the same month and year One thousand seven hundred & thirty six being the day of the return of the said Writ came the said Charles Henderson Ind. by Francis Allen his attorney and the Sheriff of Somerset County to wit Joseph Maulster Gent Lukewire Coneth and returned that by virtue of the writ aforesaid to him directed he had taken the body of the said Hugh Perkins whose body before the Justice of his Lordships County Court of Somerset at the same day and place in the writ aforesaid mentioned he had there ready &

And the said Hugh Perkins by George Douglas his attorney comes and defends the force and injury whereof and prays Leave to Imparl and he hath it and the same day is given to the said Charles Henderson here aforesaid &

At which said next Court to wit the seventh day of August and year One thousand seven hundred & thirty six came again as well the said Charles Henderson as the said Hugh Perkins by their attorneys aforesaid and because the said Charles Henderson did not prosecute his writ aforesaid against the said Hugh Perkins - Therefore he and his pledges of Bonding are in in mercy and Let the office name pledges & and that the said Hugh Perkins recover against the said Charles Henderson Ind. his damages by occasion of the premises aforesaid to
