 Kate at Colebrook Ditto against Ditto Mary Walker and Hannah Bartlett. Whereupon the Grand Jurors
 afo^r are discharged and ordered to be allowed five hundred pounds of Tobacco for their publick Service
 this Court and against the afo^r W^m Conner Abraham and Elias Lamberson W^m Hayman Jun^r
 Thomas Collins Mary Mayo Kate at Colebrook Mary Walker and Hannah Bartlett so as
