the said three pounds five shillings to the said Wrixham altho<sup>ugh</sup> by the said Wrixham on the afo<sup>r</sup>  
twenty fourth day of March in the Year afo<sup>r</sup> and often afterwards he was thereunto requested hath  
not paid or Contented but the same to him hitherto to pay or Content hath refused and shewed  
refuse and deny whereupon he saith that he is worse and hath damage to the value of six  
pounds Curr<sup>t</sup> money of Maryland and therefore he brings Suit &c.

afo<sup>r</sup> John Cragger in his proper person and whereupon the said John Cragger prays fur  
ther Leave thereof to Dispute and he hath it and the same day is given to the afo<sup>r</sup> Wrixham  
here also &c.
