Robert Jenkins Henry of Somerset County Gentleman being appointed prosecutor of his Lordship's pleas in this  
Court takes the several oaths appointed by act of assembly to be taken to the Government with the oath of  
Prosecutor, and Subscribes the oath of abjuration and test and is admitted the -

Whereupon Proclamation being made the Sheriff of Somerset County to wit Joseph M'Fester  
Genl makes return of a panel of Grand Juries as followeth vizt - John Scott David Wilson Tho.  
Williams John Woolford Wm. M'Ginnis James Neam Robert Mitchell John Whitehouse William  
Adams John Dennis John Beavis Nathaniel Horsey Joshua Caldwell John Brittingham William Kilkenny  
James Strawbridge James Martin Richard Brooks Robert Dashiel and Whereupon Proclamation being read  
by the Clerk according to Common form the Jurors afft being impanelled being severally called over by  
their names did appear as above and Whereupon they were sworn to Enquire according to the foregoing  
Commission &c according to Common form and were charged by the Chief Justice of this Court and Sealed  
to Consider &c - Soon after his Grand Jury afft being impanelled sworn and charged afft  
Somerset County, and being severally called over did appear and being asked if they had agreed on any  
Bill of Indictment return five several Bills as may here after appear to -

His Lordship - [Somerset County] The Jurors for the Right Honble the Lord Proprietary  
Peter Taylor. That now is for the body of the County as upon their oath do present that -

Peter Taylor late of Somerset County planter the twenty first day of  
December in the year of our Lord God one thousand seven hundred and thirty six at the  
Court house at Dividing Creek in the County of one dark bay Coloured Gelding being  
the proper goods and chattles of a certain John Evans with force and arms unlawfully  
did take and imprison and the same Gelding so as afft Impriected being with force -  
and arms did disfigure and from the tail of the same Gelding then and there the hairs  
thereof did with force and arms unlawfully cut off to the great damage of the said John  
Evans and against the peace of the Right Honourable the Lord Proprietary that now  
is his good rule and Government &c

This Bill Indictment sent up to the Grand Jury by Order of Court Test Thos Hayward Esq  
Tates Wm. Kitchen, John Scambrough, Jos. M'Fester, Francis Allen, John Rob't Geddes, Teague Piggott Durant
