and the same Mary then and there did beat wound and willy treat so that of her life it was much despair-
ed and other harms to her then and there did to the great damage of the same Mary and against the peace
of the said Lord Proprietary that now is his good rule and Government &c

Testes. Mary Jones: Charles Ramsey .. On the foregoing Indictment it was Endorred by True Bill
& William Jones foreman.

Thereupon Command was given to the Sheriff of Somerset County that he should take the said
Abraham and Elias Lamberson if they should be found in his bailiwick and should safe keep so
that he might have their bodies before the Justices of his Lordship's County of Somerset to be
held in the Court house at Swidung Creek in the same County the third Tuesday of March then next to
answer unto his said Lordship &c and concerning the Indictment &c for trespass and assault &c and that
whereof he should not fail &c And afterwards the third Tuesday of March to wit the fifteenth day
of the same month Anno Domini One thousand Seven hundred and thirty Six before the Justices of his Lord-
ship's County of Somerset now here held in the Court house at Swidung Creek in and for the same County
Came the said Abraham Lamberson and Elias Lamberson in their proper persons and had clearing of
the Indictment &c and they and each of them being instantly demanded how they and each of them would
acquitt themselves of the trespass and assault &c as by the Indictment &c above upon them and each
of them is imposed, say that they and each of them are not guilty thereof, and of this they and each
of them put themselves upon the Country and William Goldsborough Gent his Lordship's attorney who for his
said Lordship in that part followeth &c

Thereupon it is Commanded the Sheriff of Somerset County that Immediately he should cause to come
here before the Justices &c Twelve &c by whom &c and who without &c to recognize &c because as well &c and after-
wards Immediately came thereof the Jury &c and the Jurors of that same Jury by Joseph Muggister Gent
of the County &c to this Impanelled being called Came to wit Nicholas Fountain Joshua Sturges Charles
Townsend
