

the third Tuesday of June ^{then} next to answer unto the c^t Joshua Caldwell of Newfane^s aforesaid plea & that whereof he should not fail & likewise the said Joshua Caldwell by his attorney aforesaid complained against the said John Horsey in the plea aforesaid as followeth vizt. — Somerset County vs. John Horsey late of Somerset County planter.

Cromer of the testament of William Horsey late of the same County planter dec^d was attached to answer unto Joshua Caldwell late high Sheriff of the same County of a plea of his pay upon the same.

And whereas unto the same Joshua Caldwell by William Beckingham his attorney with whom whereof the said William Horsey in his lifetime on the first day of January in the year of our Lord seventeen hundred and thirty three at Somerset County was indebted unto the said Joshua in the sum of ten thousand nine hundred and two pounds of tobacco being for the like quantity of tobacco by the aforesaid Joshua Caldwell for the use and services of the said William Horsey there before that time at his especial instance and request laid out and expended as by an account thereof herewith into court brought may appear and so thereof being indebted the same William Horsey in his life time afterwards to wit the same day and year last mentioned at Somerset County in consideration thereof upon himself did assume and to the same Joshua Caldwell then and there faithfully did promise that he the same William Horsey the same ten thousand nine hundred and two pounds of tobacco to the same Joshua Caldwell when there of afterward he should be required well and truly would pay and content and altho the aforesaid William Horsey afterwards in his life time did pay and satisfy unto the aforesaid Joshua Caldwell seven thousand seven hundred and seventy four pounds of tobacco parcell of the aforesaid ten thousand nine hundred and two pounds of tobacco. Nevertheless as to three thousand one hundred and twenty eight pounds of tobacco the residue thereof the aforesaid William Horsey in his lifetime and the aforesaid John Horsey since the death of the said William Horsey the promise and assumption of the aforesaid William Horsey in his life time so as aforesaid made nothing regarding but plotting and fraudulently intending the same Joshua Caldwell in that part craftily and subtlely to deceive and defraud the same three thousand one hundred and twenty eight pounds of tobacco or any part thereof to the same Joshua Caldwell have not or hath either of them paid or him for the same in any sort contented altho to do the same the same William Horsey in his life time on the second day of Jan^r in the year aforesaid at the County aforesaid the aforesaid John since the death of the same William Horsey on the first day of November in the year of our Lord seventeen hundred and thirty four at the County aforesaid by the same Joshua Caldwell was required but the same to him to pay the same William Horsey in his life time and the aforesaid John since the death of the said William Horsey hitherto altogether have refused and the same to him to pay the same John still doth refuse to the damages of the same Joshua Six thousand two hundred and
