thereof being Indebted afterwards to wit the same day and year aforesaid being gone ~
beyond sea and having left his goods and Effects in the care & Management of the said ~
Andrew as his factor or agent to transact & Negotiate his affair and business to & for ~
his use and benefit during such his absence beyond sea and the said Robert for the
speedy Recovery of his debt aforesaid justly due and owing as aforesaid was about to ~
attack the said Goods and Effects of same Hugh in such manner as the Law direct for
